Town Manager Stewart briefly reviewed the creation and purpose of the Downtown Redevelopment Agency; and how the entity was kept active, but in a ‘holding pattern’, in case the Town does a project at a later date. Mr. Stewart noted this DRA meeting was simply procedural in nature.
